18A:38-1. Attendance at school free of charge

Public schools shall be free to the following persons over four and under 20 years of age:

- a. Any person who is domiciled within the school district;
- b. Any person who is kept in the home of another person domiciled within the school district and is supported by such person gratis as if he were such other person's child, upon filing by such other person with the secretary of the board of education of the district, if so required by the board, a sworn statement that he is domiciled within the district and is supporting the child gratis and will assume all personal obligations for the child relative to school requirements and that he intends so to keep and support the child gratuitously for a longer time than merely through the school term, and a copy of his lease if a tenant, or a sworn statement by his landlord acknowledging his tenancy if residing as a tenant without a written lease, and upon filing by the child's parent or guardian with the secretary of the board of education a sworn statement that he is not capable of supporting or providing care for the child, due to a family or economic hardship and that the child is not residing with the resident of the district solely for the purpose of receiving a free public education within the district. The statement shall be accompanied by documentation to support the validity of the sworn statements, information from or about which shall be supplied only to the board and only to the extent that it directly pertains to the support or nonsupport of the child;
- c. Any person who fraudulently allows a child of another person to use his residence and is not the primary financial supporter of that child and any person who fraudulently claims to have given up custody of his child to a person in another district commits a disorderly persons offense.

Resident and Child Support Affidavit

Students whose parents or legal guardians reside outside the boundaries of the Lodi School District and live in the home of any other(s) domiciled within the Borough of Lodi, require an affidavit to attend the Lodi Public Schools.

The affidavit must specify that the student resides within the school district, is being claimed as a dependent by the residents, that the student is being supported for fifty-two (52) weeks a year, seven (7) days a week. The resident/guardian is assuming all personal obligations concerning school requirements.
